19		approve the Employment & Training Annual State of Arizona - Department of						
20		Economic Security Budgets and Contract PY 2005/FY 2006 in the projected amount of						
21		\$273,519.00 and authorized to incur expenditures upon approval of this resolution						
22		from June 1, 2005 to June 30, 2006.
