Department of Health & Human Services – Native Employment Works)**

RESOLUTION NO. 05-236

1 **WHEREAS, the Department of Health & Human Services – Native Employment Works Annual**
2 **Budget has been developed with current allocation in the amount of \$150,868.00**
3 **beginning July 1, 2005 and ending June 30, 2008; and**

4 **WHEREAS, the authorized expenditure period for the Department of Health & Human Services**
5 **Native Employment Works is July 1, 2005 through June 30, 2006; and**


6 **WHEREAS, during the June 2006 Tohono O'odham Nation Legislative Council Session, the**
7 **program will request an extension to spend any remaining funds from July 1, 2006 to**
8 **June 30, 2007 each year until the grant is expired or funds have been expended to full.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
10 **approve the Employment & Training Annual Department of Health & Human Services**
11 **Native Employment Works Budget PY 2005 in the amount of \$150,868.00 and**
12 **authorized to incur expenditures upon approval of this resolution from July 1, 2005**
13 **to June 30, 2006.**

14 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**
15 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**
16 **execute the contracts and plans, provided however, that any amendment affecting**
17 **the funding or funding levels of this contract shall be submitted for further prior**
18 **approval by this Council.**

19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day**
20 **of MAY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**
21 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
22 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
23 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
24 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
