

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approval of the Employment & Training Program PY 05 Annual Program Budget  
Department of Labor - Comprehensive Service Plan)**

**RESOLUTION NO. 05-237**

1 **WHEREAS, the Department of Labor - Comprehensive Service Plan and Annual Budget has been**  
2 **developed with current projected allocation in the amount of \$368,593.00 beginning**  
3 **July 1, 2005 and ending June 30, 2008; and**

4 **WHEREAS, the authorized expenditure period for the Department of Labor - Comprehensive**  
5 **Service Plan is July 1, 2005 through June 30, 2006; and**

6 **WHEREAS, during the June 2006 Tohono O'odham Nation Legislative Council Session, the**  
7 **program will request an extension to spend any remaining funds from July 1, 2006 to**  
8 **June 30, 2007 each year until the four year grant is expired or funds have been**  
9 **expended to full; and**


10 **WHEREAS, when final allocations are received by the Department of Labor - Comprehensive**  
11 **Service Plan, the program will amend these budgets and present to the Tohono**  
12 **O'odham Legislative Council.**

13 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**  
14 **approve the Employment & Training Annual Budget Comprehensive Service Plan and**  
15 **Budget PY 2005 in the projected amount of \$368,593.00 and authorized to incur**  
16 **expenditures upon approval of this resolution from July 1, 2005 to June 30, 2006.**

17 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham**  
18 **Nation's Officials, to wit; the Chairwoman is hereby authorized to negotiate and**  
19 **execute the contracts and plans, provided however, that any amendment affecting**  
20 **the funding or funding levels of this contract shall be submitted for further prior**  
21 **approval by this Council.**

22 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup>. Day**  
23 **of MAY, 2005 at a meeting at which a quorum was present with a vote of 2,629.7 FOR; -0- AGAINST;**  
24 **-0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
25 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
26 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
27 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
