

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Adopting Legislative Branch Vehicle Policy)**

LEGISLATIVE ORDER NO. 05-251

1 **WHEREAS, Article V, Section 4 of the Constitution of the Tohono O'odham Nation vests the**
2 **Tohono O'odham Council with the power to delegate authority to the Council**
3 **Chairperson and Vice Chairperson; and**

4 **WHEREAS, on September 13, 2001, the Legislative Council adopted Legislative Order No. 01-447,**
5 **"Approving Delegation of Authority to Legislative Council Chairperson and Vice**
6 **Chairperson"; and**

7 **WHEREAS, pursuant to Legislative Order No. 01-447, the legislative officers are delegated**
8 **authority to "[a]llocate funds, staff, and other resources for the effective operation of**
9 **the Legislative Branch" and to "[a]pprove Legislative Branch expenditures"; and**

10 **WHEREAS, the Legislative Branch has purchased several vehicles for the use of Council**
11 **representatives and staff in order to conduct official legislative branch business; and**

12 **WHEREAS, vehicle use requires the appropriate allocation of vehicles, staff time, proper**
13 **maintenance, as well as the expenditure of branch funds; and**

14 **WHEREAS, use of legislative branch vehicles should be authorized and funded in a manner**
15 **which holds users accountable and serves the Tohono O'odham; and**

16 **WHEREAS, the legislative officers have developed the attached, amended "Legislative Branch**
17 **Vehicle Policy," which is incorporated by this reference, to formally "establish a**
18 **concise and enforceable vehicle policy to accommodate and protect the Legislative**
19 **Council representatives and employees while on official business" and for other**
20 **purposes.**

21 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
22 **adopts the "Legislative Branch Vehicle Policy," which shall supercede and replace all**
23 **prior Legislative Branch vehicle policies.**

24 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 20TH. Day of**
25 **MAY, 2005 at a meeting at which a quorum was present with a vote of 2,204.5 FOR; 425.2 AGAINST;**
26 **~~-0-~~ NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by Section 4 of**
27 **Article V and Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**
28 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
30 **18, 1934 (48 Stat. 984).**


