

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Certifying Election of Evelyn Juan Manuel as Chairwoman of the Tohono O'odham
Legislative Council)**

LEGISLATIVE ORDER NO. 05-256

1 **WHEREAS, during the June 6, 2005 General Session, the Legislative Council did conduct an**
2 **election for the Office of the Legislative Chairperson in accordance with Article XII,**
3 **Section 2 of the Legislative Rules; and**

4 **WHEREAS, each Representative did cast their vote for one of the candidates nominated for said**
5 **office; Councilman Verlon Jose received 448.95 votes; Councilwoman Evelyn Juan-**
6 **Manuel received 972.05 votes; Councilwoman Frances B. Conde received 698.5 votes**
7 **and Councilman Timothy Joaquin received 321.3 votes; and**

8 **WHEREAS, none of the candidates received the majority votes required to be deemed elected as**
9 **Chairperson, thereby resulting in a run off between the top two candidates, namely,**
10 **Councilwoman Frances B. Conde and Councilwoman Evelyn Juan-Manuel; and**


11 **WHEREAS, in the run off election, Councilwoman Evelyn Juan-Manuel received 1,422.7 votes and**
12 **Councilwoman Frances B. Conde received 1,018.1 votes; and**

13 **WHEREAS, Councilwoman Evelyn Juan-Manuel having received a majority of the votes cast was**
14 **declared as the Legislative Chairwoman Elect.**

15 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it does**
16 **hereby certify the election of Evelyn Juan-Manuel as Chairwoman of the Tohono**
17 **O'odham Legislative Council.**

18 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 06TH. Day of**
19 **JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
20 **-0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1(b) of**
21 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
22 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
23 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
