10 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 07th Day**
11 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
12 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Article II,**
13 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**
14 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
15 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
16 **18, 1934 (48 Stat. 984).**


