## RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL (Approving Amendment No. 2 to Attorney Contract with the Law Firm of Graham & Dunn, P.C.) RESOLUTION NO. 05-308 WHEREAS, pursuant to Resolution No. 03-186, the Tohono O'odham Legislative Council approved a line of credit to finance the expansion of gaming activity pursuant to the 2002 Compact; and

WHEREAS, pursuant to Resolution No. 03-233, attorney contracts were approved with the law firms of Vassar, Dills, Dawson & Bonfiglio, L.L.C. ("Vassar Dills") and Graham & Dunn,

P.C. ("Graham & Dunn"); and

WHEREAS, each attorney contract was in the amount of \$100,000 for the period from March 1, 2003 through May 1, 2004 and was funded under the line of credit; and

WHEREAS, pursuant to Resolution No. 04-129, the Legislative Council approved Amendment No.

1 to the attorney contracts with Vassar Dills and Graham & Dunn which extended the term of each contract through May 1, 2005; and

WHEREAS, the Attorney General recommends an extension of the Attorney Contract with Graham & Dunn through May 1, 2006 and does not recommend an extension of the attorney contract with Vassar Dills.

NOW. THEREFORE, BE IT RESOLVED THAT:

- The Tohono O'odham Legislative Council approves Amendment No. 2 to the attorney contract with Graham & Dunn, P.C., in the form attached hereto, which extends the term of the contract through May 1, 2006.
- 2. The Chairwoman of the Nation is authorized and directed to execute Amendment
  No. 2 to the attorney contract with Graham & Dunn, P.C.

The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the <u>07<sup>TH</sup>.</u> Day of <u>IUNE, 2005</u> at a meeting at which a quorum was present with a vote of <u>2,440.80</u> FOR; <u>-0- AGAINST</u>; <u>-0- NOT VOTING</u>; and <u>[04]</u> ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2) and Section 2(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
