

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Amendment No. 1 to the Attorney Contract with the Law Firm of Yoder  
& Langford, P.C.)**

**RESOLUTION NO. 05-313**

1 **WHEREAS, pursuant to Legislative Council Resolution No. 05-075, the Tohono O'odham**  
2 **Legislative Council approved an Attorney Contract with the law firm of Yoder &**  
3 **Langford, P.C. for legal services related to the 401(k) Plan of the Tohono O'odham**  
4 **Nation (the "Nation") in the amount of \$5,000 for the period from October 1, 2004**  
5 **through September 30, 2005; and**

6 **WHEREAS, additional legal services are required to protect the interests of participants in the**  
7 **401(k) Plan; and**

8 **WHEREAS, the Human Resources Officer recommends the approval of Amendment No. 1 to the**  
9 **Attorney Contract which increases the budget amount from \$5,000 to \$7,250; and**

10 **WHEREAS, the 401(k) Trustee budget (Account No. 01-3036-810) has sufficient funds for the**  
11 **increased budget amount; and**

12 **WHEREAS, the Human Resources Development Committee, the Domestic Affairs Committee and**  
13 **the Budget & Finance Committee recommend approval by the Legislative Council of**  
14 **Amendment No. 1.**

15 **NOW, THEREFORE, BE IT RESOLVED THAT:**

- 16 **1. The Tohono O'odham Legislative Council approves Amendment No. 1 to the**  
17 **Attorney Contract with the law firm of Yoder & Langford, P.C., which increases the**  
18 **budget amount from \$5,000 to \$7,250 for the period from October 1, 2004 through**  
19 **September 30, 2005, and in the form attached hereto.**
- 20 **2. Funding for Amendment No. 1 to the Attorney Contract shall be provided from the**  
21 **401(k) Trustee budget (Account No. 01-3036-810).**
- 22 **3. The Chairwoman of the Nation is authorized and directed to execute Amendment**  
23 **No. 1 to the Attorney Contract.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
25 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.8 FOR; -0- AGAINST;**  
26 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 2 (a) of**  
27 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
28 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
29 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
