

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Election Board Budget from the FY 2005 General Revenue in the**  
**amount of \$45,960.17)**

**RESOLUTION NO. 05-319**

1 **WHEREAS, the Constitution of the Tohono O'odham Nation (the Constitution) Article VI, Section**  
2 **1(d)(2) vests the Tohono O'odham Council (Legislative Council) with the power to**  
3 **manage any funds within the exclusive control of the Tohono O'odham Nation and to**  
4 **appropriate funds for the benefit of the Nation and its members; and**

5 **WHEREAS, the Constitution, Article VI, Section 1 (d)(3) vests the Legislative Council with the**  
6 **powers to adopt, approve and amend annual budgets and to authorize the**  
7 **expenditure of funds in accordance with approved budgets; and**

8 **WHEREAS, the Legislative Council did approve Resolution No. 03-564 modifying the Gaming**  
9 **Revenue Distribution Formula Authorized by Resolution No. 94-098; and**

10 **WHEREAS, the Legislative Council did approve Executive Branch, \$38,571,596.98 Resolution No.**  
11 **04-609 and 04-702; and**

12 **WHEREAS, the Tohono O'odham Election Board regulates elections for public offices in**  
13 **accordance with the Tohono O'odham Election Ordinance under Article X of the**  
14 **Tohono O'odham Nation's Constitution; and**

15 **WHEREAS, planning and preparation will require the Election Board to respond to issues**  
16 **regarding the May 2005 election results; election run-offs, recall applications and**  
17 **election contests and respond to Executive, Legislative and district concerns and**  
18 **issues; and**

19 **WHEREAS, the Election Board is requesting to utilize Executive surplus funds to support**  
20 **anticipated expenses for the remainder of the fiscal year in the amount of \$45,960.17.**

21 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
22 **approves and authorizes expenditures of the Executive revenue surplus funds from**  
23 **the 2005 General Revenue for the Tohono O'odham Election Board budget in the**  
24 **amount of \$45,960.17.**

25 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that this is a one time**  
26 **funding allocation.**

27 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 08<sup>TH</sup> Day**  
28 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 1,159.65 FOR; 974.75**  
29 **AGAINST; 306.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
31 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
32 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
33 **18, 1934 (48 Stat. 984).**
