8	WHEREAS,	the Office of the Prosecutor has identified a need to replace some high mileage
9		existing vehicles and to purchase two (2) new vehicles; and
10	WHEREAS,	funding from the Executive Surplus funds in the General Revenue for FY 2005 has
11		been identified and recommended for use and replacement of said capital
12		equipment; and
13	WHEREAS,	\$35,000 in non-recurring funding, will be allocated to the Office of the Prosecutor's
14		budget for Fiscal Year 2005 and create budget Line Item #750 designated for capital
15		equipment in said budget to purchase said capital equipment and the allocation of
16		monies will come from the Executive Surplus Funds in the General Fund Revenue;

18	WHEREAS,	the Office of the Prosecutor's FY 2005, Budget Modification No. 1 attached hereto has
19		been approved by the Office of the Chairwoman.
20	NOW, THER	REFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it
21		hereby approves the attached budget modification and authorizes the expenditure
22		of one-time funding to be allocated for the Office of the Prosecutor in the amount of
23		\$35,000 from the FY 2005 Executive Surplus Funds in the General Fund Revenue as
24		presented and attached.
