

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Nation Scholarship Fund Budget Modification 01/
Amendment No. 02)

RESOLUTION NO. 05-326

1 WHEREAS, the Tohono O'odham Nation Scholarship Fund has brought forth a Budget
2 Modification 01/Amendment No. 02 to its FY 2005 budget; and

3 WHEREAS, in Resolution No. 04-609, the Tohono O'odham Legislative Council approved the FY
4 2005 Tohono O'odham Nation Scholarship Fund in the amount of \$5,562,953.95; and

5 WHEREAS, the Tohono O'odham Nation Scholarship Fund has submitted for review and approval
6 the proposed FY 2005 Budget Modification 01/Amendment No. 02, which decreases line
7 item number 610 for Salaries & Wages and decreases line item number 620 for Fringe
8 Benefits; and


9 WHEREAS, the Tohono O'odham Nation Scholarship Fund has submitted for review and approval
10 the proposed FY 2005 Budget Modification 01/Amendment No. 02, which decreases line
11 item number 720 for Supplies-Office and adds line item number 812 for \$16,000.00 for
12 Public Relations and adds line item number 867 for \$2,000.00 for Awards.

13 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
14 and authorizes the Modification 01/Amendment No. 02 of the attached budget for the
15 Tohono O'odham Nation Scholarship Fund FY 2005.

16 BE IT FINALLY RESOLVED that the Tohono O'odham Nation Chairwoman is hereby authorized to
17 execute the budget provided that any amendments affecting the funding or funding
18 levels of this grant shall be submitted for approval by this Tohono O'odham Legislative
19 Council.

20 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day
21 of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;
22 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)
23 & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
24 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
25 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
26 Stat. 984).
