

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the FY05 Schuk Toak District Budget Modification and Amendment No. 1)**

**RESOLUTION NO. 05-327**

1 **WHEREAS, the Schuk Toak District Administration presented to the Tohono O'odham Legislative**  
2 **Council the District's FY05 Budget Amendment No. 1 which includes budget**  
3 **modifications for the fiscal year; and**

4 **WHEREAS, the District's budget modifications in its administrative budget utilizes savings in**  
5 **salaries and fringe benefits line items and does not increase the allocated total**  
6 **amounts; and**

7 **WHEREAS, the Schuk Toak District did receive Gaming Revenue in the amount of \$686,622.53;**  
8 **and**

9 **WHEREAS, the Schuk Toak District did utilize Gaming Revenue in the amount of \$655,730.50 for**  
10 **the District FY05 Budget leaving a balance of \$30,892.03; and**

11 **WHEREAS, the Schuk Toak District did receive Mining Royalties in the amount of \$55,007.80, and;**

12 **WHEREAS, the Schuk Toak District Council at a Special Meeting held on May 19, 2005 did approve**  
13 **the budget modification to the district's administrative budget and the amendment**  
14 **to its FY05 District budget, with an increase in the amount of \$69,165.60 to fund the**  
15 **district's Summer Youth Program, using \$30,892.03 from the Gaming Revenue**  
16 **balance and \$38,273.57 from the district's Mining Royalties; and**

17 **WHEREAS, there are sufficient amounts in the District accounts held by Wachovia Securities to**  
18 **cover the approved budget amendment.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves**  
20 **the Schuk Toak District FY05 Budget Modifications and the Amendment No. 1**  
21 **increase to the district base budget amount of \$655,730.50 using \$30,892.03 from the**  
22 **district's Gaming Revenue balance and \$38,273.57 from the district's Mining**  
23 **Royalties in the total amount of \$69,165.60 for a total FY05 District Budget of**  
24 **\$724,896.10 as presented to be expended in accordance with the attached budget.**

26 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09<sup>TH</sup> Day**  
27 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 1,559.25 FOR; 585.15**  
28 **AGAINST; 296.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**  
29 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
30 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
31 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
32 **Stat. 984).**


