17		approval of the State IV-B Contract, attached and incorporated herein by reference,
18		to beeffective April1, 2005throughSeptember30, 2008andrequestsapprovaltoenter
19		into and sign this Intergovernmental Agreement; and
20	WHEREAS,	the Executive Branch developed and obtained Committee approval of the FY 2005 State
21		IV-B Contract Budget in the amount of \$43,980.00, attached and incorporated by this
22		reference, to be effective April 1, 2005 through September 30, 2005 and requests
23		authorization to expend these funds in FY 2005.
