

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2004-2005 U.S. Department of Health and Human Services Title IV-B,
Subparts 1 & 2 Budgets)

RESOLUTION NO. 05-332

- 1 **WHEREAS, the Tohono O'odham Nation has historically contracted certain functions from the**
2 **U.S. Department of Health and Human Services; and**
- 3 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a**
4 **Division of Child Welfare Services to intervene against child abuse and neglect and**
5 **to promote safe and stable families; and**
- 6 **WHEREAS, the Title IV-B, Subparts 1 & 2 grants require a 25% match, which the Nation matches**
7 **through the P.L. 93-638 Master Contract, as authorized by P.L. 93-638 and the U.S.**
8 **Department of Health and Human Services; and**
- 9 **WHEREAS, in Resolution No. 03-443, the Legislative Council approved:**
- 10 **1. \$47,383.00 for FY04 Title IV-B, Subpart 1 Budget Acct. 11-1329.**
11 **2. \$109,998.01 for FY04 Title IV-B, Subpart 2 Budget Acct. 11-1330; and**
- 12 **WHEREAS, these Title IV-B, Subparts 1 & 2 Budgets are developed for spending to be authorized**
13 **beginning October 1, 2003 and ending September 30, 2005, funding the two fiscal**
14 **years of FY 2004 and FY 2005; and**
- 15 **WHEREAS, the Department of Health and Human Services has determined a final allocation**
16 **amount for these budgets as:**
- 17 **1. \$111,767.00 for Title IV-B, Subpart 1 Budget, Acct. 11-1329.**
18 **2. \$107,190.00 for Title IV-B, Subpart 2 Budget, Acct. 11-1330; and**
- 19 **WHEREAS, the Division of Child Welfare Services had partially obligated these funds as**
20 **authorized in FY 2004, leaving the following remaining balances available in FY 2005**
21 **for these budgets:**
- 22 **1. \$82,015.94 for FY05 Title IV-B, Subpart 1 Budget Acct. 11-1329.**
23 **2. \$67,351.02 for FY05 Title IV-B, Subpart 2 Budget Acct. 11-1330; and**
- 24 **WHEREAS, the Executive Branch developed and obtained committee approval of the budgets**
25 **attached and incorporated by this reference, to be effective October 1, 2004 through**
26 **September 30, 2005 and requests authorization to expend the remaining funds in FY**
27 **2005.**
- 28 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
29 **approve and authorize the Executive Branch to expend funds for the budgets**

6 Chairman and any designated official are hereby authorized to negotiate, execute
7 and expend the grant.

8 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH Day
9 of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;
10 -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of
11 Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham
12 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs
13 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


