

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 Phoenix Indian School Trust Fund Budget Modification/Amendment)

RESOLUTION NO. 05-334

1 **WHEREAS, the Tohono O'odham Nation has operated and wishes to continue operating a Division**
2 **of Child Welfare Services to intervene against child abuse and neglect; and**

3 **WHEREAS, the Department of Health and Human Services, Division of Child Welfare Services**
4 **requests to modify/amend its FY 2005 Phoenix Indian School Trust Fund budget**
5 **approved by Resolution No. 04-642, in the amount of \$133,333.33; and**

6 **WHEREAS, this budget modifies/amends certain line items and adds new line items by moving**
7 **funds saved from Personnel to Operations line items, as indicated in the attached FY**
8 **2005 Phoenix Indian School Trust Fund budget modification/ amendment, beginning**
9 **October 1, 2004 and ending September 30, 2005, in the same amount of \$133,333.33;**
10 **and**

11 **WHEREAS, the Executive Branch developed and obtained committee approval of the FY 2005**
12 **Phoenix Indian School Trust Fund budget modification/amendment attached and**
13 **incorporated by this reference, to be effective October 1, 2004 through September 30,**
14 **2005, and requests authorization to expend funds.**

15 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
16 **approve and authorize the Executive Branch to expend funds for the FY 2005 Phoenix**
17 **Indian School Trust Fund budget modification/amendment attached, retroactive to**
18 **October 1, 2004 through September 30, 2005, with modified/ amended line items and**
19 **new line items, in the amount of \$133,333.33.**

20 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman,**
21 **Vice-Chairman and any designated official are hereby authorized to negotiate,**
22 **execute and expend the grant.**

23 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 09TH. Day**
24 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,273.4 FOR; -0- AGAINST;**
25 **-0- NOT VOTING; and 167.4 [05] ABSENT, pursuant to the powers vested in the Council by Section**
26 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
27 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
28 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
29 **Stat. 984).**
