

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Fresnal Canyon Community, Baboquivari District FY 2005 Budget**  
**Modification/Amendment #1)**

**RESOLUTION NO. 05-339**

1 WHEREAS, on May 16, 2005 the Baboquivari District Council was presented with a Budget  
2 Amendment to the FY 2005 Annual Budget in the amount of \$1,000.00 (One thousand  
3 Dollars and 00/100) by the Fresnal Canyon Community Representatives; and

4 WHEREAS, the Community of Fresnal is in agreement to add to the FY 2005 Budget a new line  
5 item 751.32 - Lease & Rental and by approval shall transfer funds in the amount of  
6 1,000.00 from line item 750.32 - major Capital Equipment.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham legislative Council hereby approves  
8 the Fresnal Canyon Community FY 2005 Budget Modification/Amendment #1 to add  
9 to the new line item 751-32 - Lease & Rentals in the amount of 1, 000.00 which does  
10 not effect the total base budget of \$141,964.37.



14 167.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1  
15 (d)(3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono  
16 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -  
17 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48  
18 Stat. 984).
