**RESOLUTION NO. 05-341**

1 **WHEREAS, pursuant to Legislative Council Resolution Nos. 01-128, 03-085, and 04-249**  
2 **concerning the use of Asset Forfeiture Funds; and**  
3 **WHEREAS, the Tohono O'odham Nation Police Department is requesting for the authorization**  
4 **and expenditure of funds to purchase 11 bushmaster rifles and 14 glock handguns**  
5 **including accessories; and**  
6 **WHEREAS, the total cost of this acquisition is \$29,961.25.**  
7 **NOW, THEREFORE, BE IT RESOLVED that the Legislative Council hereby accepts and approves the**  
8 **authorization and expenditure for the acquisition to purchase 11 bushmaster rifles**  
9 **and 14 glock handguns including accessories for the total budgeted amount of**  
10 **\$29,961.25 to be funded from the Asset Forfeiture Fund Account - Department of**  
11 **Justice, Account No. 0046-78008-3507.**

12 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10<sup>TH</sup> Day**  
13 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
14 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
15 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
16 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
17 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
