

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Accepting, Approving and Authorization of Budget Amendment #1 for 638 BIA
Budget 10-1090 for Tohono O'odham Nation Police Department (TONPD))**

RESOLUTION NO. 05-342

1 **WHEREAS, the Tohono O'odham Nation with a land base of 2.8 million acres and a population of**
2 **27,000 members, contracts its own Law Enforcement, Corrections and Ranger**
3 **Programs under the 638 BIA Master Contract; and**
4 **WHEREAS, the Tohono O'odham Nation Police Department (TONPD) has received an increase of**
5 **\$1,380,484.00 under the BIA 638 Master Contract; and**
6 **WHEREAS, has identified a need for an additional position of Emergency Management**
7 **Administrator; and**
8 **WHEREAS, has also identified the program needs for a minimum of 20 vehicles, two (2) on/off**
9 **road motorcycles and one (1) trailer; and**
10 **WHEREAS, also the need for program supplies for inmates usage; and kitchen equipment,**
11 **including utensils; and**
12 **WHEREAS, in order to purchase such equipment and supplies, two new lines must be established**
13 **as 10-1090-722 Program Supplies to be used for inmate supplies; and 10-1090-724**
14 **Supplies-Kitchen to be used for kitchen equipment less than \$5,000 per single item**
15 **and kitchen utensils; and**
16 **WHEREAS, TONPD is requesting the Tohono O'odham Nation Legislative Council for the approval**
17 **of Budget Amendment #1 for the addition of one new position of Emergency**
18 **Management Administrator; and**
19 **WHEREAS, for the acquisition of a minimum of 20 vehicles, two (2) on/off road motorcycles and**
20 **one (1) trailer; and two new line items.**
21 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it**
22 **hereby accepts, approves and authorizes the increased final allocation amount of**
23 **\$1,380,484.00 funding; the establishment of two new line items account number 10-**
24 **1090-722 Program Supplies and 10-1090-724 Supplies-Kitchen to the FY 2005 Tohono**
25 **O'odham Nation Police Department 638 BIA Budget.**
26 **BE IT FURTHER RESOLVED the new position of Emergency Management Administrator to be**
27 **effective July 1, 2005.**

1 **BE IT FURTHER RESOLVED Budget Amendment #1 in the amount of \$1,238,085.47 (Direct costs of**
2 **\$1,118,644.00 and Indirect cost of \$55,441.47) to be expended for the acquisition of a**
3 **minimum of 20 vehicles, 2 on/off road vehicles, one (1) trailer; program supplies for**
4 **inmate usage and kitchen equipment and utensils.**

5 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby**
6 **authorized to negotiate and execute the budget provided that any amendments**
7 **affecting the funding or funding levels of this budget shall be submitted for approval**
8 **by the Tohono O'odham Nation Legislative Council.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 10TH Day**
10 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,019.80 FOR; -0- AGAINST;**
11 **421.0 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)**
12 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
13 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
14 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
