(Override of Vetoed Resolution No. 05-338, "Approval of Mr. David Fazzino's Proposal
entitled Tohono O'odham Traditional Foods: Conservation and Utilization of Seeds
as Sources of Identity, Meaning, Health and Culture")

RESOLUTION NO. 05-351

1 **WHEREAS, during the June 10, 2005 General Session of the Tohono O'odham Legislative Council,**
2 **the Council did pass Resolution No. 05-338, "Approval of Mr. David Fazzino's Proposal**
3 **entitled Tohono O'odham Traditional Foods: Conservation and Utilization of Seeds as**
4 **Sources of Identity, Meaning, Health and Culture"; and**

5 **WHEREAS, upon presentation of Resolution No. 05-338 to the Chairwoman of the Tohono**
6 **O'odham Nation, she did disapprove thereof and returned it to the Council with her**
7 **objections in accordance with the provisions of Article VII, Section 5 of the**
8 **Constitution of the Tohono O'odham Nation; and**

9 **WHEREAS, during the June 27, 2005 Special Session, the Chairwoman presented to the Legislative**
10 **Council her justification in vetoing Resolution No. 05-338, a copy of which is attached**
11 **hereto; and**

12 **WHEREAS, the Legislative Council reviewed the Chairwoman's objections and after**
13 **consideration, again voted to pass Resolution No. 05-338.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby**
15 **override the Chairwoman's veto by a vote of two-thirds of the votes cast in accordance**
16 **with the provisions of Article VII, Section 5 of the Constitution of the Tohono O'odham**
17 **Nation.**

18 **The foregoing Resolution was presented to the Tohono O'odham Legislative Council on the 27TH,**
19 **day of JUNE, 2005 at a meeting at which a quorum was present, and by a vote of 1,379.5 FOR; 193.1**
20 **AGAINST; 699.2 NOT VOTING; and 169.0 [02] ABSENT, was passed by a vote of two-thirds (2/3)**
21 **[1,048.4] of the votes cast as required by Section 5 of Article VII of the Constitution of the Tohono**
22 **O'Odham Nation.**
