4		General Revenue Surplus Funding and Authorizing a Divided Percentage Allocation
5		to the Legislative, Judicial and Executive Branch) provides executive surplus funds
6		for an initial tri-branch employee alcohol and drug testing program (\$24,500), and
7		the purchase of a copier (\$12,000) for a total of \$36,500; and
8	WHEREAS,	\$36,500 in non-recurring funding will be allocated to the Human Resources budget
9		for FY-2005 for initial alcohol and drug testing program and to purchase capital
10		equipment utilizing the Executive surplus funds; and
11	WHEREAS,	the Human Resources Office has identified in its operational dollars to supplement
12		the surplus amount for purchase of a copier; and
13	WHEREAS,	the Human Resources Office has identified the need to create a new position for
14		Training Specialist and identified funds by freezing one vacancy and utilizing funds
15		from 612.5 Other Compensation line item; and
16	WHEREAS,	the General Support Services, Human Resources Office, FY-2005 Budget Amendment
17		No. 1 has been reviewed and approved by the Office of the Chairwoman, the Human
18		Resources Development and Budget & Finance Committees.
19	NOW, THER	EFORE, BE IT RESOLVED by the Tohono O'odham Nation Legislative Council that it
20		hereby approves and authorizes the expenditure of one-time funding to be allocated
21		for the General Support Services, Human Resources, Budget Amendment No. 1, for
22		an initial tri-branch employee alcohol and drug testing program (\$24,500), and the
23		purchase of a copier (\$12,000) for a total of \$36,500.
