

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Acceptance, Approval and Authorization for Compensation Adjustment for Corrections Staff and to Fund Four (4) New Positions Under the 638 BIA Master Contract that will be Recurring and the Establishment of a New Account Number)**

RESOLUTION NO. 05-358

1 **WHEREAS, the Tohono O'odham Nation has contracted its own Law Enforcement, Corrections and**  
2 **Ranger Programs under the 638 BIA Master Contract; and**

3 **WHEREAS, the TONPD has identified a need to retain Corrections Officers under the Corrections**  
4 **Division; and**

5 **WHEREAS, TONPD did an "average compensation pay study" for Corrections Staff with the**  
6 **surrounding agencies of: Maricopa, Pima and Pinal Counties; the Gila River Agency**  
7 **and Salt River Agency; the average salary for a TONPD Corrections Officer is below the**  
8 **compensation scale of those surrounding agencies; and**

9 **WHEREAS, to retain current Corrections Officers and to attract new officers and staff, the**  
10 **compensation of the Corrections Staff need to be increased: 1) TONPD needs to be**  
11 **competitive with the surrounding agencies; and 2) to attract new officers and retain**  
12 **officers; Corrections Staff salaries need to be adjusted; and**

13 **WHEREAS, TONPD is requesting to adjust the compensation in the amount of \$146,613.50 of**  
14 **Direct Costs and Indirect cost of \$67,457.72 for the Corrections Staff to be effective July**  
15 **1, 2005; and**

16 **WHEREAS, TONPD has identified the need for additional staff in the Corrections Division for one:**  
17 **(1) Registered Nurse; one (1) Administrative Assistant; one (1) Corrections Cook and**  
18 **one (1) Assistant Corrections Administrator.**

19 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
20 **accepts, approves and authorizes the expenditure of BIA 638 Funds for a**  
21 **compensation adjustment for the Corrections Staff and to fund the four new positions:**  
22 **one (1) Registered Nurse; one (1) Administrative Assistant; one (1) Corrections Cook**  
23 **and one (1) Assistant Corrections Administrator to be effective July 1, 2005.**

24 **BE IT FURTHER RESOLVED that these funds will be "recurring" and authorizes the Accounting**  
25 **Department to establish a new account number to be maintained and tracked**  
26 **separately for the Corrections Division under TONPD.**

27 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation Vice Chairman is hereby authorized**  
28 **to negotiate and execute the budget provided that any amendments affecting the**




1 funding or funding levels of this budget shall be submitted for approval by the Tohono  
2 O'odham Nation Legislative Council.

3 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27<sup>TH</sup>. Day  
4 of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,230.3 FOR; -0- AGAINST;  
5 210.5 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f)  
6 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
7 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
8 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).


