

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Authorizing a Budget Modification/Amendment No. 1 to Account Number 11-1268 (IMLS Enhancement Grant, Venito Garcia Library and Archives))

RESOLUTION NO. 05-363

1 **WHEREAS, the Tohono O'odham Legislative Council has historically supported the Venito Garcia**
2 **Library and Archives, the library agency for the Tohono O'odham Nation; and**

3 **WHEREAS, the Tohono O'odham Legislative Council has accepted an Enhancement Grant for the**
4 **Venito Garcia Library and Archives from the Institute of Museum and Library Services**
5 **(Native American Library Services) and authorized spending these funds on a library**
6 **outreach project to connect three Tohono O'odham libraries (Venito Garcia Library**
7 **and Archives, San Lucy District Library, San Xavier Learning Center Library) with a**
8 **common catalog, systemic intra-library loan, and mutual borrowing conventions.**

9 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council authorizes the**
10 **creation of a new line item 650 (Tuition and Registration) in account number 11-1268**
11 **with the amount of \$ 1,100.00 in this new line item 650, with the funds coming from**
12 **line item 660 (\$842.65) and from line item 722 (\$257.35).**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 27TH Day**
14 **of JUNE, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
15 **-0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**
16 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
17 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
18 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
