7 **this Nation, and does hereby order that their name(s) be deleted from the**
8 **membership roll.**

9 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11th Day**
10 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,344.25 FOR; -0 AGAINST;**
11 **96.55 NOT VOTING; and [05] ABSENT, pursuant to the powers vested in the Council by Article II,**
12 **Section 3 and Article IV, Section 1 (h) of the Constitution of the Tohono O'Odham Nation, adopted**
13 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
14 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
15 **18, 1934 (48 Stat. 984).**




