

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(FY 2005 Judicial Budget Modification #01 P.L. 93-638)**

RESOLUTION NO. 05-375

1 WHEREAS, on December 07, 2004 the Tohono O'odham Legislative Council Resolution No. 04-612
2 approved the P.L. 93-638 Master Contract in the amount of \$11,695,621.35, which
3 allocated \$342,790.11 for Judicial Services; and
4 WHEREAS, according to the United States Department of the Interior Office of Self-Determine a
5 modification to the Nation's Master Contract reduces the original allocation for
6 Judicial Services; and
7 WHEREAS, this reduction does decrease the amount authorized by the Tohono O'odham
8 Legislative Council by \$1,842.24 resulting in a reduction from \$342,790.11 to
9 \$340,947.87 (Attachment) for Judicial Services.
10 NOW, THEREFORE, BE IT RESOLVED that due to a modification by the United States Department
11 of the Interior the original allocation for Judicial Services be reduced from
12 \$342,790.11 to \$340,947.87.
13 BE IT FINALLY RESOLVED that the Judicial Services Budget Modification #01 reflects the final
14 allocation of \$340,947.87 under P.L. 93-638 Tohono O'odham Nation contract for the
15 Justice Center.

16 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 11TH Day
17 of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;
18 -0- NOT VOTING; and -0- ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)
19 & (3) of Article VI of the Constitution of the Tohono O'odham Nation, adopted by the Tohono
20 O'odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
21 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
22 Stat. 984).
