

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of Changing the Department of Human Service Title to the Department
of Health and Human Services)**

RESOLUTION NO. 05-379

1 **WHEREAS, in September 1994, Resolution No. 94-393, the Tohono O'odham Legislative Council**
2 **approved the consolidation structure of the Health Department, Department of**
3 **Social Service and the Needy Family Food Program hereafter to be referred to as the**
4 **Department of Human Services; and**

5 **WHEREAS, there is often confusion to the Department's name because Human Service refers to**
6 **the Social Services' program, and does not clearly recognize the Health programs**
7 **component within the Department; and**

8 **WHEREAS, the Department would be more appropriately and accurately described as the**
9 ***Department of Health and Human Services*, instead of the Department of Human**
10 **Service.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Nation Executive Office and Tohono**
12 **O'odham Legislative Council approve to change the Department's title from**
13 **Department of Human Service to the *Department of Health and Human Services*.**

14 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
15 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
16 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (l) of**
17 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**
18 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**
19 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
