

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Tohono O'odham Department of Human Services, Division of Behavioral Health-FY2005 Behavioral Health I.H.S. Contract Modification #1, Account No. 10-1473)

RESOLUTION NO. 05-382

1 **WHEREAS, the Department of Human Services, Division of Behavioral Health is currently**
2 **operating the Behavioral Health Division through an Indian Health Services (I.H.S.)**
3 **P.L. 93-638 contract, third party revenues and I.H.S. carryover monies; and**

4 **WHEREAS, the Department of Human Services, Division of Behavioral Health provides substance**
5 **abuse and mental health services; and**

6 **WHEREAS, the Division of Behavioral Health is modified to increase line items in the following**
7 **line items: insurance, tuition and registration, travel expense, utilities,**
8 **communication expenses, office supplies, lease/rental, repair & maintenance-**
9 **vehicles, consultant expenses, special activities and indirect cost; and decrease the**
10 **professional services line item; and**

11 **WHEREAS, the Professional Services is decreased which increases the Indirect Cost by \$7,385.72.**

12 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council:**

- 13 **1. Hereby approves and authorizes expenditures in accordance with the FY 2005**
14 **Behavioral Health I.H.S. Contract Modification #1, Account No. 10-1473 to**
15 **increase line items: insurance, tuition and registration, travel expense, utilities,**
16 **communication expenses, office supplies, lease/rental, repair & maintenance-**
17 **vehicles, consultant expenses, special activities and indirect cost; and decrease**
18 **the professional services line item.**
- 19 **2. The Professional Services is decreased which increases the Indirect Cost by**
20 **\$7,385.72.**
- 21 **3. The Tohono O'odham Nation's Officials to wit: the Chairwoman and Vice**
22 **Chairman and any designated official are hereby authorized to negotiate and**
23 **execute the proposal.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
25 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 1,960.5 FOR; -0- AGAINST;**
26 **-0- NOT VOTING; and 480.3 [10] ABSENT, pursuant to the powers vested in the Council by Section**
27 **1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**
