1 **WHEREAS, the Tohono O'odham Nation, Division of Human Services is presently operating the**  
2 **Division of Special Needs; and**

3 **WHEREAS, any modifications affecting the funding or funding levels of the Department shall be**  
4 **submitted for review and approval by the Tohono O'odham Legislative Council; and**

5 **WHEREAS, the Division of Special Needs has submitted the attached budget Modification**  
6 **#1/Amendment #1 for review and approval. The budget modification includes a new**  
7 **line item, 750 Major Capital Equipment.**

8 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 9 **1. It hereby approves and authorizes budget Modification #1/Amendment #1 and**  
10 **authorizes a new line item, 750 Major Capital Equipment.**
- 11 **2. Any modifications affecting the funding or funding levels of the Department shall**  
12 **be submitted for review and approval by the Tohono O'odham Legislative Council.**
- 13 **3. The Tohono O'odham Nation's Officials to wit: the Chairwoman is hereby**  
14 **authorized to execute the budget modification/amendment.**

15 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day**  
16 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.8 FOR; -0- AGAINST;**  
17 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (f) of**  
18 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
19 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
20 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**
