

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approval of FY 2006 DHHS - Division of Community Health /Tuberculosis Control
Services Program Budget)

RESOLUTION NO. 05-385

1 **WHEREAS, the Tohono O'odham Nation has operated the Tuberculosis Control Services Program**
2 **to help prevent the spread of the disease through community education, prevention,**
3 **early detection, comprehensive regimens and careful follow up with individuals; and**
4 **WHEREAS, funding for the operation of the Tohono O'odham Tuberculosis Control Services**
5 **Program has been provided in part through supplemental funding sources; and**
6 **WHEREAS, the Division of Community Health - Tuberculosis Control Services desires to continue**
7 **the services it provides to TB susceptible patients; and**
8 **WHEREAS, the Tohono O'odham Tuberculosis Control Services Program has received funding**
9 **from the State of Arizona, Department of Health Services for its program; and**
10 **WHEREAS, a budget in the amount of \$20,000.00 is submitted for review and approval by the**
11 **Department of Human Services, Tohono O'odham Nation Legislative oversight**
12 **committees, Health & Human Services and the Budget & Finance utilize funds to**
13 **continue the services it provides.**

14 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that:**

- 15 **1. It hereby approves the funding of the Tohono O'odham Tuberculosis Control**
16 **Services Program from the State of Arizona Department of Health Services and**
17 **approves expenditures in accordance with the attached budget in the amount of**
18 **\$20,000.00.**
- 19 **2. That the duration of this contract shall be retroactive from July 01, 2005 and**
20 **remain in effect as long as the Arizona Department of Health Services agrees to**
21 **fund the Tohono O'odham Tuberculosis Control Services Program.**
- 22 **3. The Tohono O'odham Nation Officials, to wit: the Chairwoman and Vice**
23 **Chairman and any designated Official are hereby authorized to negotiate and**
24 **execute this contract.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 12TH Day**
26 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**
27 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**
28 **& (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
29 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
30 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
31 **Stat. 984).**
