ı	WHEREAS,	the Tohono O'odham Nation conducted a general election on Saturday, May 28, 2005
2		for the offices of representatives and alternates to the Tohono O'odham Legislative

4	WHEREAS,	on May 29, 2005 the Election Board issued and posted its Certification of Election
5		Results, incorporated herein by this reference, pursuant to Section 6(K) of Article VII
6		of the Uniform Election Ordinance; and
7	WHEREAS,	Section 6(N) of Article VII of the Uniform Election Ordinance requires that the
8		Legislative Council issue Certificates of Election to, and seat, the candidates who
9		$receive the \ highest number of votes for each Council seat, provided \ however, that any$
10		person elected to public office who holds another elective public office of the Nation
11		must resign before being seated; and
12	WHEREAS,	while the Council did seat the majority of Legislative Council alternates elected in the
13		2005 general election pursuant to Resolution No. 05-253, it was necessary for Gu Vo
14		District Alternate to the Legislative Council Grace Manuel to resign another elective
15		office prior to being seated.
16	NOW, THER	EFORE, BE IT RESOLVED that the Chairwoman and Secretary of the Tohono O'odham
17		Legislative Council are hereby authorized and directed on behalf of the Council to
18		execute and deliver a Certificate of Election seating Grace Manuel as the Gu Vo
19		District Alternate to the Tohono O'odham Legislative Council, who shall hold her
20		office for a term of four (4) years from June 6, 2005 or until her successor has been
21		elected, certified and seated.
