RESOLUTION NO. 05-402

1 WHEREAS, the Sif-Oidak District Council met on July 9, 2005 to finalize Fiscal Year 2006 Budget;

2 and

3 WHEREAS, the Sif-Oidak District Budget can not be finalized due to the Gaming Revenue  
4 Distribution amount not being available; and


5 WHEREAS, the Sif-Oidak District does have sufficient funds in their account to continue  
6 operations.

7 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does hereby  
8 approve the Sif-Oidak District Continuing Resolution.

9 BE IT FINALLY RESOLVED that the Sif-Oidak District Council does have sufficient funds to continue  
10 operations during this period.

11 The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day  
12 of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;  
13 -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)  
14 of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham  
15 Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs  
16 (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).




