**RESOLUTION NO. 05-404**

1 **WHEREAS, Tohono O'odham Legislative Council Resolution No. 05-365 title reads: Resolution of**  
2 **the Tohono O'odham Legislative Council (Road Priorities FY2005 Thru FY2010); and**

3 **WHEREAS, the title needs to be changed to: Resolution of the Tohono O'odham Legislative**  
4 **Council (Road Priorities FY 2005 Thru 2009); and**

5 **WHEREAS, the dates will match the Schedule of Projects listing (attachment B) in Transportation**  
6 **Improvement Plan (TIP) under appendix I; and**


7 **WHEREAS, the Natural Resources Committee has reviewed what needs to be corrected and**  
8 **agrees there needs to be a change of dates to be consistent with the Schedule of**  
9 **Projects (attachment B) in the Transportation Improvement Plan.**

10 **NOW, THEREFORE, BE IT RESOLVED, that the Legislative Council has reviewed Resolution No.**  
11 **05-365 Road Priorities FY2005 Thru FY2010 and the Schedule of Projects (attachment**  
12 **B) under Transportation Improvement Plan (TIP) and sees the need for change of**  
13 **dates recommended made by the Natural Resources Committee.**

14 **BE IT FURTHER RESOLVED that Tohono O'odham Road Priorities is FY 2005 Thru 2009 to be**  
15 **consistent with the Schedule of Projects listing.**


16 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
17 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
18 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (j) of**  
19 **Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
20 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
21 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


