

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving the Solid Waste Management Program FY05 Budget Amendment 1 (10-1097))**

**RESOLUTION NO. 05-405**

1 **WHEREAS, the Tohono O'odham Legislative Council adopted the Solid Waste Management Code**  
2 **and Solid Waste Management Plan on February 12, 1997 with Resolution No. 97-041,**  
3 **which in part created the Solid Waste Management Program (SWMP); and**

4 **WHEREAS, the SWMP has expanded its scope of work since its inception in 1997 to include**  
5 **community dumpsite closure; and**

6 **WHEREAS, to accomplish this expanded scope of work SWMP has hired additional staff and**  
7 **apply for and receive additional grants; and**

8 **WHEREAS, for the dumpsite closure to be successful, a full-time Solid Waste Foreman is needed**  
9 **to supervise the additional staff; and**


10 **WHEREAS, the SWMP proposes, with the support from the Human Resources Office, the**  
11 **reclassification of the Laborer position to the Solid Waste Foreman position.**

12 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
13 **approves the SWMP FY05 Budget Amendment 1 for the reclassification of the Laborer**  
14 **position to the Solid Waste Foreman position, as per attached Budget.**

15 **BE IT FINALLY RESOLVED that the Tohono O'odham Nation's officials to wit: the Chairwoman and**  
16 **any designated official are hereby authorized to negotiate and execute the Grant,**  
17 **provided however, that any amendments affecting the funding or funding levels of**  
18 **this Grant shall be submitted for further prior approval by the Tohono O'odham**  
19 **Legislative Council.**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 14<sup>TH</sup> Day**  
21 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.8 FOR; -0- AGAINST;**  
22 **-0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)**  
23 **(3) & (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
24 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
25 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
26 **Stat. 984).**
