

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Chukut Kuk District FY 2005 Budget Amendment No. 1)

RESOLUTION NO. 05-419

1 WHEREAS, the Tohono O'odham Legislative Council did approve Chukut Kuk District FY 2005
2 Budget and Justification by Resolution No. 04-593; and

3 WHEREAS, funds were allocated to the ten recognized communities in Chukut Kuk District for
4 youth and community needs as determined by the communities; and

5 WHEREAS, community budgets with justifications were submitted to the Chukut Kuk District
6 office; and

7 WHEREAS, San Miguel Community is amending their budget to include line items not identified
8 in the original budget justification.

9 NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves
10 Chukut Kuk District FY 2005 Budget Amendment No. 1, which shall include the
11 following items:

Community Budget


- 12 - Labor Costs
- 13 - Purchase items for community building: cooler, windows, doors, etc.
- 14 - Assistance for apartment rent payment, utility payment

Youth Budget

- 15 - Assistance for rent payment for college students
- 16 - Conferences and or Sports Activities
- 17 - Purchase youth activity supplies
- 18 - Clothing grants for grades K-12

22 of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.8 FOR; -0- AGAINST;
23 -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)
24 & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono
25 O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -
26 Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48
27 Stat. 984).
