

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Revising and Increasing FY 2005 Projected Revenue by \$1,470,000)**

**RESOLUTION NO. 05-422**

1 **WHEREAS, the Legislative Council is vested with the power "to manage any funds within the**  
2 **exclusive control of the Tohono O'odham Nation, including proceeds derived from**  
3 **lands and resources of the Tohono O'odham Nation, and to appropriate these funds**  
4 **for the benefit of the nation and its members." (Constitution of the Tohono O'odham**  
5 **Nation, Article VI, Section 1(d)(2)); and**

6 **WHEREAS, pursuant to Resolution No. 04-323, the Council approved "projected revenues in the**  
7 **amount of \$49,493,008 for the purpose of funding the FY 2005 budgets of the Tohono**  
8 **O'odham Nation"; and**

9 **WHEREAS, actual and projected FY 2005 revenues available to fund the Nation's budgets are**  
10 **\$1,470,000 greater than the revenues projected prior to the beginning of the current**  
11 **fiscal year pursuant to Resolution No. 04-323; and**

12 **WHEREAS, the Budget and Finance Committee is delegated the power to recommend legislative**  
13 **measures necessary to manage the Nation's funds (Plan of Operation for the Budget**  
14 **and Finance Committee, Article 1(b)); and**

15 **WHEREAS, the Budget and Finance Committee has reviewed revisions to the Nation's FY 2005**  
16 **projected revenues with representatives of the executive and judicial branches, and**  
17 **has recommended to the Tohono O'odham Council that the revisions be adopted.**

18 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**  
19 **revises and increases the Nation's FY 2005 projected revenues from \$49,493,008 by**  
20 **\$1,470,000 to \$50,963,008.**

21 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25<sup>TH</sup> Day**  
22 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0- AGAINST;**  
23 **-0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by Section 1 (d)(2)**  
24 **of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono O'Odham**  
25 **Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary - Indian Affairs**  
26 **(Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).**


