

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2006 Distribution of Gaming Revenues by Equal Distribution)**

RESOLUTION NO. 05-424

1 **WHEREAS, during the July 20, 2005 Budget & Finance Committee meeting, the committee met**
2 **with the Chairwoman and discussed three options on the distribution of gaming**
3 **revenues for consideration by the Legislative Council: 1) equal distribution; 2)**
4 **population distribution; and 3) 50/50 distribution (½ equal and ½ population)); and**

5 **WHEREAS, the preliminary District distribution projection reports are attached and represent**
6 **an increase of \$1,621,791.33 in total District distributions; and**

7 **WHEREAS, District distributions are to be disbursed on August 1, 2005 and the final District**
8 **distribution numbers will not be available until August 30, 2005, therefore resulting**
9 **in some minor fluctuations.**

10 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'odham Legislative Council that it hereby**
11 **approves and authorizes the FY 2006 distribution of gaming revenues by equal**
12 **distribution.**

13 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 25th, Day**
14 **of JULY, 2005 at a meeting at which a quorum was present with a vote of 1,450.3 FOR; 990.5**
15 **AGAINST; -0- NOT VOTING; and [-0-] ABSENT, pursuant to the powers vested in the Council by**
16 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
17 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
18 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
19 **18, 1934 (48 Stat. 984).**
