(Setting Special Session for August 16, 2005 to Address the Miss Tohono O'odham Nation Six (6) month update and the Tohono O'odham Community College Board of Trustee Appointments)

LEGISLATIVE ORDER NO. 05-437

1 **WHEREAS, Article VI, Section 1 (a) of the Constitution of the Tohono O'odham Nation empowers**
2 **the Legislative Council "[T]o establish rules and procedures to regulate all meetings**
3 **of the Tohono O'odham Council, standing committees, boards, and special**
4 **committees"; and**

5 **WHEREAS: the Human Resources Development Committee requests that a special session be**
6 **held on Tuesday August 16, 2005 to address Miss Tohono O'odham Nation Six (6)**
7 **month Update and the Tohono O'odham Community College Board of Trustee**
8 **Appointments; and**

9 **WHEREAS: the Human Resources Development Committee will be meeting along with the Rules**
10 **Committee to complete the appointment process.**

11 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**
12 **schedules a Special Session for Tuesday August 16, 2005 to address Miss Tohono**
13 **O'odham Nation six (6) month update and the Tohono O'odham Community College**
14 **Board of Trustee Appointments.**

15 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 03RD, Day of**
16 **AUGUST, 2005 at a meeting at which a quorum was present with a vote of 2,273.4 FOR; -0-**
17 **AGAINST; 167.4 NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
18 **Section 1 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
19 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
20 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
21 **18, 1934 (48 Stat. 984).**
