

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving FY 2005 Attorney Contract for John M. Neis to serve as a Conflict Attorney)

RESOLUTION NO. 05-444

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to retain John M. Neis to be appointed to represent**
5 **clients with conflicts of interest who cannot be represented by the Nation's Advocate**
6 **Program; and**

7 **WHEREAS, the Advocate Program has presented a contract for John M. Neis which confirms and**
8 **ratifies the terms and conditions related to his services, a copy of which is attached;**
9 **and**

10 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**
11 **a Conflict Attorney Contract with John M. Neis on such terms.**

12 **NOW, THEREFORE, BE IT RESOLVED:**

- 13 **1. The Tohono O'odham Legislative Council ratifies and approves the Conflict**
14 **Attorney Contract for John M. Neis in the forms attached hereto for the period of**
15 **August 1, 2005 through September 30, 2005 in an amount not to exceed \$25,000.00**
16 **total.**
- 17 **2. Funding for the Conflict Attorney Contract for John M. Neis shall be provided under**
18 **the operating budget of the Advocate Program for fiscal year 2005.**


19 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04TH Day**

24 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
25 **18, 1934 (48 Stat. 984).**


