

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving Addendum to FY05 Conflict Attorney Contract for David Juarez)**

**RESOLUTION NO. 05-445**

1 **WHEREAS, there are no other attorneys to handle conflicts which the Nation's Advocate Program**  
2 **is not ethically allowed to handle in the increasing needs of tribal members for legal**  
3 **representation in civil and criminal matters; and**

4 **WHEREAS, the Advocate Program wishes to increase funding of the existing Conflict Attorney**  
5 **Contract with Conflict Attorney David Juarez to represent clients with conflicts of**  
6 **interest who cannot be represented by the Nation's Advocate Program; and**

7 **WHEREAS, the Advocate Program has presented an Addendum to the FY05 Conflict Attorney**  
8 **Contract for David Juarez which increases the funding of his contract by \$5,000.00, for**  
9 **a total of \$85,000.00, and which confirms and ratifies the existing terms and conditions**  
10 **related to his services, a copy of which is attached; and**

11 **WHEREAS, the Domestic Affairs Committee recommends approval by the Legislative Council of**  
12 **the Addendum to FY05 Conflict Attorney Contract with Conflict Attorney David Juarez**  
13 **on such terms.**

14 **NOW, THEREFORE, BE IT RESOLVED:**

- 15 **1. The Tohono O'odham Legislative Council ratifies and approves the Addendum to**  
16 **the Conflict Attorney Contract with Conflict Attorney David Juarez in the forms**  
17 **attached hereto for the period of August 1, 2005 through September 30, 2005,**  
18 **increasing the amount of his Conflict Attorney Contract by \$5,000.00 for a total not**  
19 **to exceed \$85,000.00.**
- 20 **2. Funding for the increase in the Conflict Attorney Contract for David Juarez shall**  
21 **be provided under the operating budget of the Advocate Program for fiscal year**  
22 **2005.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 04<sup>TH</sup> Day**  
25 **of AUGUST, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
26 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
27 **Section 2 (a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
28 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
29 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
30 **18, 1934 (48 Stat. 984).**
