

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving the Appointment of Councilwoman Cynthia Manuel as the Tucson Area**  
**Representative to the National Indian Health Board)**

**RESOLUTION NO. 05-447**

- 1 **WHEREAS, the National Indian Health Board (NIHB) is a non-profit organization representing**  
2 **federally recognized tribes in the United States in advocating for the improvement of**  
3 **health care delivery; and**
- 4 **WHEREAS, Area Health Boards serve as the communication link between the NIHB and the Indian**  
5 **tribes on policy issues; and**
- 6 **WHEREAS, Area Health Boards have an advisory role in planning, project design, and activities**  
7 **involving tribal and Alaska Native programs; they obtain information, ideas, review**  
8 **public opinion and proposals; and**
- 9 **WHEREAS, in areas where there is no Area Health Board, the NIHB representative takes**  
10 **responsibility for communicating policy issues and concerns to the tribes in that area;**  
11 **and**
- 12 **WHEREAS, since 1972 the Tohono O'odham Nation has had a representative to serve on the**  
13 **National Indian Health Board; and**
- 14 **WHEREAS, in accordance with NIHB By-Laws, "NIHB Representatives are required to be a Tribal**  
15 **Official, i.e. Council, Health Board, Health Director, etc. . . ."; and**
- 16 **WHEREAS, the Legislative Council has historically selected and appointed a new representative**  
17 **to NIHB every two years, and**
- 18 **WHEREAS, former Legislative Councilman Dennis Ramon served as the member on the NIHB**  
19 **representing the Tucson Area, but resigned his office as a Legislative Council**  
20 **Representative effective May 31, 2005; and**
- 21 **WHEREAS, the Health and Human Services Committee recommends that Legislative**  
22 **Councilwoman Cynthia Manuel replace former Councilman Dennis Ramon as the**  
23 **Tucson Area representative to the NIHB.**
- 24 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council does**  
25 **hereby select and appoint Councilwoman Cynthia Manuel to replace former Dennis**  
26 **Ramon as Area Representative to the NIHB, and shall serve until June 2007 or until**  
27 **leaving or vacating her elected office.**
- 28 **BE IT FINALLY RESOLVED that this Resolution shall supercede and replace all prior resolutions**  
29 **appointing the Tucson Area Representative to NIHB.**



4 **Section 1 (b), (c)(2) and (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted**  
5 **by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
6 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
7 **18, 1934 (48 Stat. 984).**






