## **RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL** (Approving the SXCA Budget Modification/Amendment #2)

1	RESOLUTION NO. <u>05-453</u>
2	WHEREAS,in August 18, 2004, the Tohono O'odham Legislative Council (TOLC) approved funding
3	to the San Xavier Cooperative Association (SXCA), from the Nation's SAWRSA Trust
4	Fund in the amount of \$348,965.00 (TOLC Resolution No. 04-397); and
5	WHEREAS, this funding provided for operational and capital needs for the San Xavier Cooperative
6	Association for a six-month period from October 1, 2004 through March 31, 2005; and
7	WHEREAS,the SXCA has expended the appropriated funds per the budget that was approved by
8	the TOLC and finds that the budget needs to be modified/amended; and
9	WHEREAS, the SXCA now wishes to modify this budget to cover deficits within line item 618 – Fuel
10	and to add funds in the amount of \$12,699.13 which will come from the Personnel and
11	Payroll Expenses line items, which has sufficient funds; and
12	WHEREAS, after this modification the SXCA wishes to add funds to new line items 616–Farm tools
13	and supplies; 701 – Office/Janitorial supplies; and 619 – Cost of Construction; and
14	WHEREAS, the SXCA has submitted its request to the appropriate Legislative Committees, Budget
15	and Finance, Agricultural and Water Resources, which have reviewed the proposed
16	modification and amendment request.
17	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby approves
18	the budget modification/amendment #2 to cover deficits.
19	BE IT FINALLY RESOLVED that the Tohono O'odham Legislative Council also approves the budget
20	amendment to add new line items 616 (Farm tools/supplies); 619 (Cost of Construction)
21	and 701 (Office/Janitorial supplies) and authorizes the expenditure of these funds to
22	September 30, 2005.
