

RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 04-367, "Approving the Sif-Oidak District FY '05 Budget,"
to Reflect Actual Amounts and Identify New Funding Sources)

RESOLUTION NO. 05-460

1 **WHEREAS, on August 05, 2004, the Tohono O'odham Legislative Council enacted Resolution**
2 **Number 04-367, "Approving the Sif-Oidak District FY '05 Budget," which became**
3 **effective August 10, 2004; and**

4 **WHEREAS, the Sif-Oidak District Council has reviewed the funding sources for FY 2005 and is**
5 **recommending some adjustments to reflect the actual amounts received and to**
6 **identify new funding sources; and**

7 **WHEREAS, Resolution No. 04-367 identified the Investment Savings of \$926,326.23, carry over**
8 **funds of \$270,000, and the El Paso Gas Line right-of-way payment of \$115,814.65; and**

9 **WHEREAS, the Sif-Oidak District, through Resolution No. 07-05-24, is recommending that its FY**
10 **2005 Budget funding from the Investment Savings of \$926,326.23 be deleted; and**

11 **WHEREAS, the Sif-Oidak District Council has further requested an adjustment to its FY 2005**
12 **Budget to reflect the actual amount of \$116,319.84 received from the El Paso Gas Line**
13 **right-of-way payment; and**

14 **WHEREAS, Resolution No. 07-05-24 also includes new funding sources from the Gaming Revenues,**
15 **\$750,956.83; Mining Revenues, \$60,161.85; and District Savings Account, \$114,702.36**
16 **to be used toward the FY 2005 budget.**

17 **NOW, THEREFORE, BE IT RESOLVED by the Tohono O'Odham Legislative Council that it does**
18 **hereby amend Resolution No. 04-367 to:**

19 **(1) amend the FY 2005 Sif Oidak District Council Budget funding from the El Paso Gas**
20 **Line right-of-way payment to \$116,319.84 from \$115,814.65;**

21 **(2) approve new funding sources for the FY 2005 Sif Oidak District Council Budget to**
22 **include the following: Gaming Revenues, \$750,956.83; Mining Revenues, \$60,161.85**
23 **and the District Savings of \$114,702.36; and**

24 **(3) delete funding from Investment Savings in the amount of \$926,326.23.**

25 **BE IT FURTHER RESOLVED that the amendments to Resolution No. 04-367 made herein shall be**
26 **effective retroactive to August 10, 2004.**

1 **BE IT FINALLY RESOLVED by the Tohono O'odham Legislative Council that, effective retroactive**
2 **to August 10, 2004, the Sif Oidak District is authorized to expend FY 2005 Gaming**
3 **Revenues in accordance with the amendments to Resolution No. 04-367 made herein,**
4 **provided that such expenditures are otherwise valid pursuant to all applicable laws**
5 **and policies.**



8 **of AUGUST, 2005 at a meeting at which a quorum was present with a vote of 2,271.8 FOR; -0-**
9 **AGAINST; 169.0 NOT VOTING; and [04] ABSENT, pursuant to the powers vested in the Council by**
10 **Section 1 (d)(1) & (2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by**
11 **the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
12 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
13 **18, 1934 (48 Stat. 984).**




