

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Setting the September 22, 2005 Special Session Regarding Economic Development**  
**Authority Matters)**

**LEGISLATIVE ORDER NO. 05-481**

1 **WHEREAS, according to the Legislative Rules, Article I, Section 1.D.1., "The Legislative Council**  
2 **may, by majority vote, call for a Special Session to be held for the purposes of**  
3 **completing unfinished agenda, addressing issues requiring an Executive Session,**  
4 **and/or reviewing special reports from Committees, Programs or other sources."; and**

5 **WHEREAS, pursuant to Section 5(d)(15) of the "Economic Development Authority of the Tohono**  
6 **O'odham Nation Charter and Plan of Operation,"**

7 **The Economic Development Board will "Make a formal report regarding**  
8 **the Authority's operations to the Chairperson of the Tohono O'odham**  
9 **Nation and the Legislative Council within 45 days of the close of the**  
10 **Authority's fiscal year, including a summary of the budget that the**  
11 **Economic Development Board has approved for the succeeding fiscal**  
12 **year."; and**

13 **WHEREAS, the Legislative Council Commerce Committee has requested that a special session be**  
14 **set for September 22, 2005 to address the following Economic Development Authority**  
15 **items:**

- 16 **1. EDA Audits**
- 17 **2. EDA Annual Reports**
- 18 **3. Sells Shopping Center Conceptual Plans**
- 19 **4. La Princessa Update (Rocky Point)**

20 **NOW, THEREFORE, BE IT ORDERED that the Tohono O'odham Legislative Council hereby**  
21 **sets a special session for September 22, 2005 to address the following Economic**  
22 **Development Authority items:**

- 23 **1. EDA Audits**
- 24 **2. EDA Annual Reports**
- 25 **3. Sells Shopping Center Conceptual Plans**
- 26 **4. La Princessa Update (Rocky Point)**

27 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 12<sup>TH</sup> Day of**  
28 **SEPTEMBER 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
29 **AGAINST; -0- NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
30 **Section 1(a) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**  
31 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**  
32 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**  
33 **Stat. 984).**


