6		provides emergency dispatch services to the Tohono O'odham Nation Fire				
7		Department for the Nation's San Xavier District at an agreed price per dispatched				
8		call; and				
9	WHEREAS,	the parties have agreed to continue the mutually beneficial arrangement for an				
10		additional year at the price of \$25.00 per dispatched call, increased from \$22.00 per				
11		dispatched call, and to execute a new Emergency Dispatch Services Agreement which				
12		includes a Non-Availability of funds clause to limit the Nation's liability pending final				
13		budget approval for Fiscal Year 2006; and				
14	WHEREAS,	the agreement shall be in effect for the time period October 1, 2005 to September 30,				
15		2006; and				
16	WHEREAS,	the Domestic Affairs Committee and the Budget and Finance Committee have				
17		reviewed the proposed agreement and recommends approval by the Legislative				
18		Council.				
19	NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby					
20		approves the Emergency Dispatch Services Agreement with Drexel Heights Fire				
21		District substantially in the form attached hereto, and authorizes the Chairwoman				
22		of the Tohono O'odham Nation to execute it and any further amendments extending				
23		the term of the agreement.
