

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving Emergency Dispatch Services Agreement Between the Nation and
Drexel Heights Fire District for FY 2006)**

RESOLUTION NO. 05-490

1 **WHEREAS, the Tohono O'odham Nation entered into an intergovernmental agreement called an**
2 **Emergency Dispatch Services Agreement with the Drexel Heights Fire District on or**
3 **about August 16, 2002, and it has been extended annually by Legislative Council**
4 **resolution through September 30, 2005; and**

5 **WHEREAS, under the Emergency Dispatch Services Agreement the Drexel Heights Fire District**
6 **provides emergency dispatch services to the Tohono O'odham Nation Fire**
7 **Department for the Nation's San Xavier District at an agreed price per dispatched**
8 **call; and**

9 **WHEREAS, the parties have agreed to continue the mutually beneficial arrangement for an**
10 **additional year at the price of \$25.00 per dispatched call, increased from \$22.00 per**
11 **dispatched call, and to execute a new Emergency Dispatch Services Agreement which**
12 **includes a Non-Availability of funds clause to limit the Nation's liability pending final**
13 **budget approval for Fiscal Year 2006; and**

14 **WHEREAS, the agreement shall be in effect for the time period October 1, 2005 to September 30,**
15 **2006; and**

16 **WHEREAS, the Domestic Affairs Committee and the Budget and Finance Committee have**
17 **reviewed the proposed agreement and recommends approval by the Legislative**
18 **Council.**

19 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**
20 **approves the Emergency Dispatch Services Agreement with Drexel Heights Fire**
21 **District substantially in the form attached hereto, and authorizes the Chairwoman**
22 **of the Tohono O'odham Nation to execute it and any further amendments extending**
23 **the term of the agreement.**

24 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
25 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
26 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**
27 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
28 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
29 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
30 **Stat. 984).**




