

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Approving the FY 2006 Annual Funding Agreement with the Indian Health Service)**

RESOLUTION NO. 05-491

1 **WHEREAS, the Tohono O'odham Nation has for many years contracted with the Indian Health**
2 **Service of the United States Department of Health and Human Services under Public**
3 **Law 93-638 to perform health related programs, functions, services and activities;**
4 **and**

5 **WHEREAS, the Indian Health Service and the Tohono O'odham Nation have agreed to continue**
6 **the P.L. 93-638 contract for an additional year under an Annual Funding Agreement**
7 **for FY 2006 in the anticipated total amount of \$3,903,753, including the same**
8 **programs contracted for in the previous year; and**


9 **WHEREAS, the Tohono O'odham Nation is not adding any new programs in the FY 2006 Annual**
10 **Funding Agreement; and**

11 **WHEREAS, the Health and Human Services Committee and the Budget and Finance Committee**
12 **have reviewed the FY 2006 Annual Funding Agreement and recommend approval by**
13 **the Legislative Council.**

14 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council approves the**
15 **FY 2006 Annual Funding Agreement with the Indian Health Service substantially in**
16 **the form attached hereto in the anticipated total amount of \$3,903,753, and**
17 **authorizes the Chairwoman of the Nation to execute it.**

18 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 13TH Day**
19 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
20 **AGAINST; -0- NOT VOTING; and [06] ABSENT, pursuant to the powers vested in the Council by**
21 **Section 1 (f) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the Tohono**
22 **O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant Secretary -**
23 **Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June 18, 1934 (48**
24 **Stat. 984).**


