

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL**  
**(Approving FY 2006 Baboquivari District and Community Budgets)**

RESOLUTION NO. 05-508

1 **WHEREAS, at a scheduled district meeting on August 18, 2005 the Baboquivari District Council**  
2 **did approve the gaming distribution in the amount of \$1,098,428.82; and**

3 **WHEREAS, the district council allocated 40% to the district administration in the amount of**  
4 **\$439,371.52 and 60% to the six (6) communities in the amount of \$659,057.28 to be**  
5 **divided equally at \$109,842.88; and**

6 **WHEREAS, on September 10, 2005 the Baboquivari District Council did review and approve the**  
7 **FY 2006 Baboquivari District and Community Budgets in the amounts as follows:**

18 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby**  
19 **approves the FY 2006 Baboquivari District and Community Budgets in the amount of**  
20 **\$1,098,428.82 to be distributed with 40% to the District Administration (\$439,371.52)**  
21 **and 60% to the six (6) Communities (\$109,842.88 each) for a total of \$659,057.28 per**  
22 **attached budgets.**

23 **BE IT FINALLY RESOLVED that any additional monies from gaming distribution shall be brought**  
24 **forward for approval by the Tohono O'odham Legislative Council.**

25 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 15<sup>TH</sup> Day**  
26 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
27 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
28 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
29 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
30 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
31 **18, 1934 (48 Stat. 984).**


