

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Approving Sells District Administration and Communities FY-2006 Budget)**

**RESOLUTION NO. 05-511**

1 **WHEREAS, the Sells District Administration Officials presented the District's Administration**  
2 **Budget which includes the four communities (Sells Community, Big Field**  
3 **Community, Cowlic Community and North Communities) for the fiscal budget year**  
4 **2006 to the Tohono O'odham Legislative Council for review and approval; and**

5 **WHEREAS, the Sells District FY-2006 Budget is in the amount of One Million, Ninety Eight**  
6 **Thousand, Four Hundred Twenty Eight Dollars and Eighty Two Cents (\$1,098,428.82)**  
7 **this amount covers the cost for the Sells District Administration in the amount of**  
8 **\$1,018,428.82 and includes the four communities; Sells Community, Big Field**  
9 **Community, Cowlic Community and North Communities. Each community is**  
10 **budgeted in the amount of Twenty Thousand Dollars (\$20,000.00) and the four**  
11 **communities budget totals Eighty Thousand Dollars (\$80,000.00) at which the grand**  
12 **total is One Million, Ninety Eight Thousand, Four Hundred Twenty Eight Dollars and**  
13 **Eighty Two Cents (\$1,098,428.82); and**

14 **WHEREAS, the Tohono O'odham Legislative Council did review and approve the Sells District**  
15 **Administration FY-2006 Budget.**

16 **NOW, THEREFORE, BE IT RESOLVED THAT the Tohono O'odham Legislative Council did review and**  
17 **approve the Sells District Administration FY-2006 Budget in the amount of One**  
18 **Million, Ninety Eight Thousand, Four Hundred Twenty Eight Dollars and Eighty Two**  
19 **Cents (\$1,098,428.82).**

20 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day**  
21 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**  
22 **AGAINST; -0- NOT VOTING; and [03] ABSENT, pursuant to the powers vested in the Council by**  
23 **Section 1 (d)(2) & (3) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**  
24 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**  
25 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**  
26 **18, 1934 (48 Stat. 984).**




