

**LEGISLATIVE ORDER OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL  
(Amending the Legislative Branch Vehicle Policy Adopted by Legislative Order No. 05-251)**

**LEGISLATIVE ORDER NO. 05-516**

1 **WHEREAS, Article V, Section 4 of the Constitution of the Tohono O'odham Nation vests the**  
2 **Tohono O'odham Council with the power to delegate authority to the Council**  
3 **Chairperson and Vice Chairperson; and**

4 **WHEREAS, on September 13, 2001, the Legislative Council adopted Legislative Order No. 01-447,**  
5 **"Approving Delegation of Authority to Legislative Council Chairperson and Vice**  
6 **Chairperson"; and**

7 **WHEREAS, pursuant to Legislative Order No. 01-447, the Legislative Officers are delegated**  
8 **authority to "[a]llocate funds, staff, and other resources for the effective operation of**  
9 **the Legislative Branch" and to "[a]pprove Legislative Branch expenditures"; and**

10 **WHEREAS, by Legislative Order No. 05-251, the Council adopted the Legislative Branch Vehicle**  
11 **Policy developed by the Legislative Officers; and**

12 **WHEREAS, Section IV(I) of the Policy provides that "Passengers who are not employees or Council**  
13 **representatives shall not be transported in legislative vehicles."; and**

14 **WHEREAS, the Legislative Branch administration has determined that Section IV(I) does not**  
15 **meet the needs of the Branch when certain situations arise; and**

16 **WHEREAS, it is therefore in the Branch's best interest to amend the Legislative Branch Vehicle**  
17 **Policy to delete this provision.**

18 **NOW, THEREFORE, BE IT ORDERED by the Tohono O'odham Legislative Council that it hereby**  
19 **deletes Section IV(I) from the "Legislative Branch Vehicle Policy" adopted by**  
20 **Legislative Order No. 05-251.**

21 **The foregoing Order was passed by the Tohono O'odham Legislative Council on the 16<sup>TH</sup> Day of**  
22 **SEPTEMBER 2005 at a meeting at which a quorum was present with a vote of 1,891.7 FOR; -0-**  
23 **AGAINST; 549.1 NOT VOTING; and [02] ABSENT, pursuant to the powers vested in the Council by**  
24 **Article V, Section 4 and Article VI, Section 1 (I) of the Constitution of the Tohono O'Odham Nation,**  
25 **adopted by the Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy**  
26 **Assistant Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act**  
27 **of June 18, 1934 (48 Stat. 984).**
