

**RESOLUTION OF THE TOHONO O'ODHAM LEGISLATIVE COUNCIL
(Amending Resolution No. 05-423, "Approving FY 2006 Preliminary Projected Revenues
in the Amount of \$49,546,296")**

RESOLUTION NO. 05-527

1 **WHEREAS, the Legislative Council is vested with the power "to manage any funds within the**
2 **exclusive control of the Tohono O'odham Nation" (Constitution of the Tohono**
3 **O'odham Nation, Article VI, Section 1(d)(2)); and**

4 **WHEREAS, the Legislative Council previously adopted FY 2006 Projected Revenues in the amount**
5 **of \$49,546,296 (Resolution No. 05-423); and**

6 **WHEREAS, the Budget and Finance Committee has recommended that the FY 2006 Projected**
7 **Revenues be amended and increased by \$179,008, thereby increasing the total FY 2005**
8 **Surplus to \$1,319, 822; and**

9 **WHEREAS, the Budget and Finance Committee recognizes that the total amount of the FY 2006**
10 **Projected Revenues will increase from \$49,546,296 to a new total of \$49,725,304.**

11 **NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby amends**
12 **and increases the Nation's FY 2006 Projected Revenues by \$179,008, thereby increasing**
13 **the total FY 2005 Surplus to the amount of \$1,319,822.**

14 **BE IT FINALLY RESOLVED that the FY 2006 Projected Revenue total is hereby increased from**
15 **\$49,546,296 to a new total of \$49,725,304, and Resolution No. 05-423 is amended**
16 **accordingly to reflect this new total projected revenue amount.**

17 **The foregoing Resolution was passed by the Tohono O'odham Legislative Council on the 26TH Day**
18 **of SEPTEMBER, 2005 at a meeting at which a quorum was present with a vote of 2,440.80 FOR; -0-**
19 **AGAINST; -0- NOT VOTING; and [01] ABSENT, pursuant to the powers vested in the Council by**
20 **Section 1 (d)(2) of Article VI of the Constitution of the Tohono O'Odham Nation, adopted by the**
21 **Tohono O'Odham Nation on January 18, 1986; and approved by the Acting Deputy Assistant**
22 **Secretary - Indian Affairs (Operations) on March 6, 1986, pursuant to Section 16 of the Act of June**
23 **18, 1934 (48 Stat. 984).**




