| 4 | WHEREAS, the GAP Grant is a 4-year continuation grant with a project period that extends from |
| 5 | August 1, 2002 through July 31, 2006 which requires annual applications for new |
| 6 | funding; and |
| 7 | WHEREAS, the TONEPA has applied for an additional \$260,085 for FY06, the fourth year of the |
| 8 | current 4-year cycle; and |
| 9 | WHEREAS, the USEPA has set aside this amount, which will be awarded in Assistance Amendment |
| 10 | GA-97924901-4; and |
| 11 | WHEREAS, accumulative current tribal budget needs to be correspondingly amended to a total |
| 12 | of \$1,195,333. |
| 13 | NOW, THEREFORE, BE IT RESOLVED that the Tohono O'odham Legislative Council hereby accepts |
| 14 | the FY06 award of \$260,085 of new funding for the continuation of the GAP grant. |
| 15 | BEIT FURTHER RESOLVED that the GAP Budget, 11-5118 is hereby added to the expended amount |
| 16 | of \$935,248 existing funds for a total budget of \$1,195,333 as described in the attached |
| 17 | continuation budget. |
| 18 | BE IT FURTHER RESOLVED by the Tohono O'odham Legislative Council that the Tohono O'odham |
| 19 | Nation's Official, to wit: the Chairwoman, Vice-Chairman and any designated official |
| 20 | are authorized to negotiate and execute the grant, provided however, that any |
| 21 | amendments affecting the funds or funding levels of the grant shall be submitted for |
| 22 | further prior approval. |
| 23 | BE IT FINALLY RESOLVED that the TONEPA GAP Program is authorized to expend the funds in the |
| 24 | amount of \$260,085 beginning October 1, 2005 through the grant period, which |
| 25 | commenced August 1, 2002 and runs through July 31, 2006. |
